## Michelle:

Michelle is on the Idaho Charter network board now from Bluum. Treasure Valley Classic, Elevate, Alturas, GemPrep also on the board.
Karina van Pelt has been hired as our fellow through Bluum to train for 2 years to run the Rigby elementary.
Jennifer from Bluum came up and did a review, particularly over the Special Ed services. It went well; she'll be bringing other Bluum schools to come and learn from us.
Hillary from JKAF board will come in early April
Mike Caldwell over academics will come.
Hollister from Twin Falls is interested in modeling their school after Alturas. Teachers and school leaders have been visiting.
Charter in Lava is also considering modeling their school after Alturas.
Trainer came in for training to support best practices in discipline and classroom management.
Went really well; we were already quite aligned.
Covey leadership training previously went well; so now students will receive leadership training, Leader in Me, next year. We have a grant to support half the costs.
Leadership training for school leaders, teachers. Board is invited Apr 12, 2024.
Did meetings for 5th graders coming to 6th and 8th graders coming into 9th, and other meetings for parents as well, about the middle school and high school offerings.

Charter will be submitted in the August commission meeting. Funding for land, etc. will be secured so we can move forward. Charter needs to be written and approved before funding.
