ADDENDUM AGREEMENT

AGREEMENT made this 10th day of Aug, 2022, by and between Alturas International Academy Charter School District #495 151 N Ridge Ave Idaho Falls, ID 83402 ("Charter School") and Teton Stage Lines, Inc., an Idaho Corporation, PO Box 51455, Idaho Falls, Idaho, 83405-1455 ("Contractor").

WHEREAS, on the 22nd day of Aug, 2016, the parties entered into a Transportation Agreement for a term of five (5) year term;

WHEREAS, the Charter School and Contractor are continuing to work under the terms of the existing Contract that has been signed by both parties;

WHEREAS, pursuant to Idaho Code Section #33-1510 The Board of Trustees of Alturas International Academy Charter School District #495 and the contractor Teton Stage Lines may renew the contract for the term not to exceed the (5) five additional years;

WHEREAS, the School has expressed a desire to extend the contract for only 3 additional years;

WHEREAS, Section XVII of the existing contract allows for a cost of living increase based upon the increase (or decrease) in the Consumer Price Index (C.P.I.-U); and that amount is established at 8.6% or \$0.40 per mile additional;

WHEREAS, the price for fuel was \$3.07 per gallon and the C.P.I.-U would raise the base price of fuel the same 8.6% to \$3.33 per gallon;

WHEREAS, the Contractor has raised the extra curriculum service rate to \$75.00 per hour with a two hour minimum call out;

WHEREAS, the Contractor has met with the School regarding adding additional costs per routes to reflect the pay increase being offered to drivers by the school of \$3.00 per hour divided by the minimum of 50 miles per day; adding an additional \$0.60 per mile in driver wages;

WHEREAS, the previous year's mileage rate was run at the rate of \$4.65 per mile,

NOW THEREFORE, the parties hereby agree that transportation services will continue to be effective from 22 August 2016 until the last day of school, on or about 01 Jul 2024 unless sooner terminated in accordance with the provisions of the contract and that all terms of the existing contract shall remain in place with the following amendments:

- SECTION ELEVEN (ATTACHMENT A) shall be amended to specify:
 - o A rate of \$5.65 per mile
 - o Base Fuel established at \$3.33 per gallon
 - Extra Curriculum service \$75.00 per hour
